Extra workers may be needed for Tradeshow work in San Francisco, San Jose, and Santa Clara

The most likely days in September in San Francisco are the 6th, 7th, 8th, 9th, 14th and 15th. And in San Jose September 9th, 10th, 14th and 15th.

(EXTRA) UNION TRADE SHOW INSTALLER INFORMATION

JOB DESCRIPTION: Installers set up and remove exhibits, displays, signage, carpets, furniture, pipe

& drape, and other display materials for conventions, trade shows and special

events.

REQUIREMENTS & ID: YOU MUST BE 18 YEARS OF AGE. Federal law requires proof of citizenship when reporting to work for a new employer. You can satisfy this requirement by bringing a United States Passport or two of the following ID's when you are dispatched to a new employer: drivers license, social security card, birth certificate.

CITIZENSHIP You must meet all requirements of the United States Government.

ELIGIBILITY:

WAGE SCALE: You will be working under the Local 510 Trade Show and Convention

Installer's Contract. For Building Trades Workers the hourly straight-time wage is \$28.39; Time and One Half: \$42.59; Double Time: \$56.78 (B List

rate), less \$1.00/hour administrative check off.

Pay Day – Each employer pays weekly regardless of hours worked. You will not be paid at layoff – your paycheck will be mailed to you after the end of the weekly pay period.

TOOL REQUIRMENTS: You are expected to have the following tools when you work:

Claw Hammer Diagonal or Side Cutters
Pliers Work Apron with Pockets or

Small & Large Flat Screwdriver Tool Belt with a Pouch

6" to 10" Crescent Wrench Small Pry Bar ("Wonder" or Flat Bar)

An Arrow JT21 or Markwell L4 Staple Gun

DISPATCH: You may ONLY BE DISPATCHED to work by Local 510's Union

Dispatcher. After you phone the (1-650) 871-8391 message line and are told that work is available for Extras (which will be you), you will be given a number to call and talk to the Dispatcher. Please identify yourself as a Craft Worker. If dispatched, please sign in under the "B" classification and understand that the Union is not your employer.
